# Legislative Committee News

## National Flood Insurance Program

The National Flood Insurance Program has been overhauled by Congress and was signed by the President on July 6, 2012. There are a number of issues that are important to communities in New Jersey, including implications for pre-FIRM properties, repetitive loss structures, substantially damaged

structures, and for new and lapsed properties. Also notable is that annual policy rate increases will apply to all policies. The GAO has estimated that rates could increase as much as 2 to 2.5 times over the next four years.

While the implications and outcomes are yet to be seen in full, the reforms may provide incentive for additional buyouts, elevations and greater par-



ticipation by communities in the Community Rating System program.

# Community Rating System Committee News

The NJAFM CRS Committee submitted comments to the draft 2013 CRS Coordinator's Manual as part of the review process for the Manual update. The Draft version of the manual has been posted in a temporary website (www.CRS2012.org) as a reference to communities as they plan to reduce flood vulnerabilities. This draft is being used in the Office of Management and

Budget approval process and is expected to become effective in 2013.

Some highlights of the draft include a new activity (370-Promotion of Flood Insurance). Some items raise concern for New Jersey regarding eligibility for credits (420 and 630), enhanced mitigation incentives (330 and 340), resource requirement impacts (370), and re-

duced credits for acquisition and relocation activities (520).
